Old Business

- a. Individual Work Group Update Reports: Felecia provided an update for the Access to Care (ATC) Task Group on behalf of Dr. Amy Anderson and the Education and Messaging Task Group. Dr. Johnny Johnson provided an update for the Prevention Task Group, the current state of water fluoridation in Pinellas County. - b. Approval of the 2012-2013 Strategic Plan (S.P.): The final draft of the strategic plan developed by Dr. Layman, co-chair and edited by Felecia Brantley was introduced for approval. Karen proposed that the coalition vote on the acceptance of the four (4) goals featured in the S.P. and allow the Task Groups (now called Work Groups) to develop their own strategies. This proposal request was accepted and approved by the coalition members.

New Business

- a. <u>Naming the Task Groups</u>: The subcommittees for the Coalition are referred to as Task Groups, a motion was made by Karen, Chair to vote on what they should be called; Task Group, Work Group, or Subcommittee. The winning vote was Work Group. Effective immediately all Task Groups will be called Work Groups.
- b. <u>Guest Speaker, Dr. Johnny Johnson:</u> Johnny discussed the current state of the water fluoridation in Pinellas County. He provided the coalition members with an abbreviated letter he submitted



to the Pinellas County Dental Association (PCDA) on the topic. He indicated that Fluoridation is a political issue and as individuals we must support candidates that support fluoridation by 1) donating time and/or money 2) reach out to our network to spread the word 3) educate the non-medical community about the benefits of fluoridation. Johnny will provide the coalition Fact Sheet to use by the end of September.

- c. <u>Give Kids a Smile 2013:</u> The event day is February 22, 2013. The first planning meeting was held on Tuesday, September 11th at Dr. Sonji Jackson's office.
